

Your privacy is important for Barend Houtsmuller Photography. This Privacy Policy describes how we deal with your personal information. We inform you about how we provide access to your personal data and how you can change or delete your data.

In order to be able to provide good service, it is necessary that we have access to your personal data and that we can use it in the context of our assignment. The General Data Protection Regulation (GDPR) describes what your rights and obligations are related to privacy and how we take care of your personal data.

Your right to privacy

Personal information about you is recorded within our company. As a customer you are entitled to protect your personal data. Barend Houtsmuller Photography has taken appropriate measures to protect your personal data against data leaks or any form of unlawful processing. We also use encryption on our website.

Other companies or individuals who have access to your data on behalf of Barend Houtsmuller Photography are directly or indirectly involved with the work we do for you.

Processing your data

Barend Houtsmuller Photography processes your personal data only if:

1. You have given permission to do so
2. The processing is needed for the realization of the contract with the person involved;
3. Barend Houtsmuller Photography must comply with the European or Dutch law.
4. A legitimate interest of Barend Houtsmuller Photography exists, which also means offering commercial products and services to this person involved.

What happens to your personal data?

The processing of personal data does not include more data than is strictly necessary for the purpose of the work involved. The information we store is basic information such as name and address, e-mail, telephone number, and your bank account number. When data is processed for other purposes, your explicit permission is required for this, unless the data is anonymous.

If you entered personal details on our website, we will only use this information for handling your application, such as an introductory appointment for a photo shoot or answering a question. Your data will not be used for other purposes and will never be provided to third parties. Your data will be destroyed within a reasonable time after processing your request.
